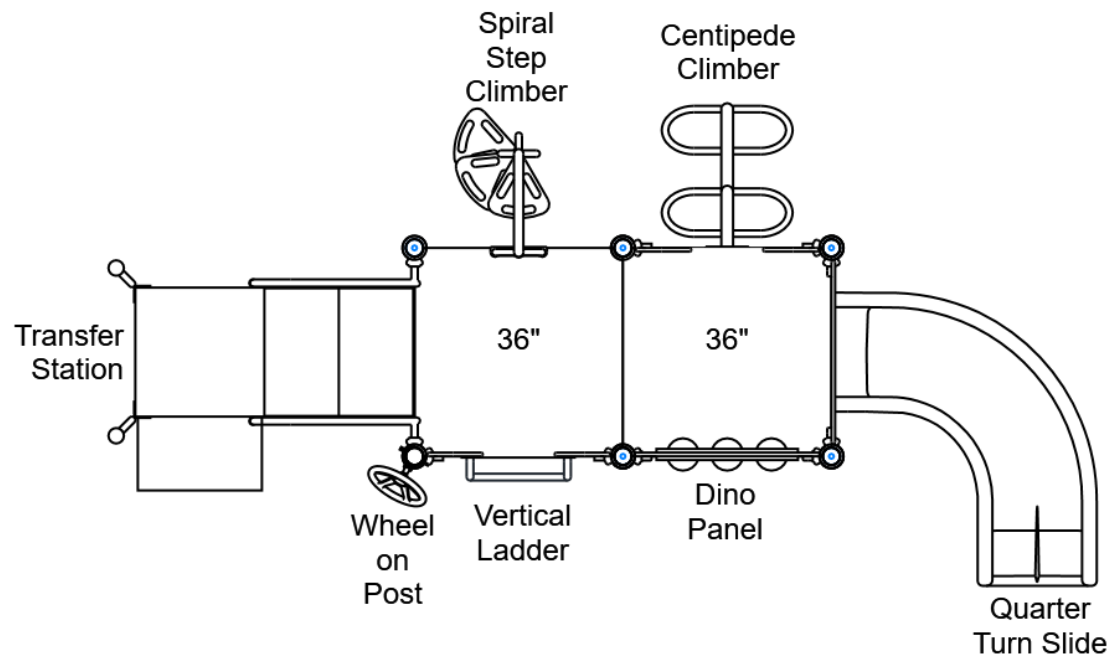

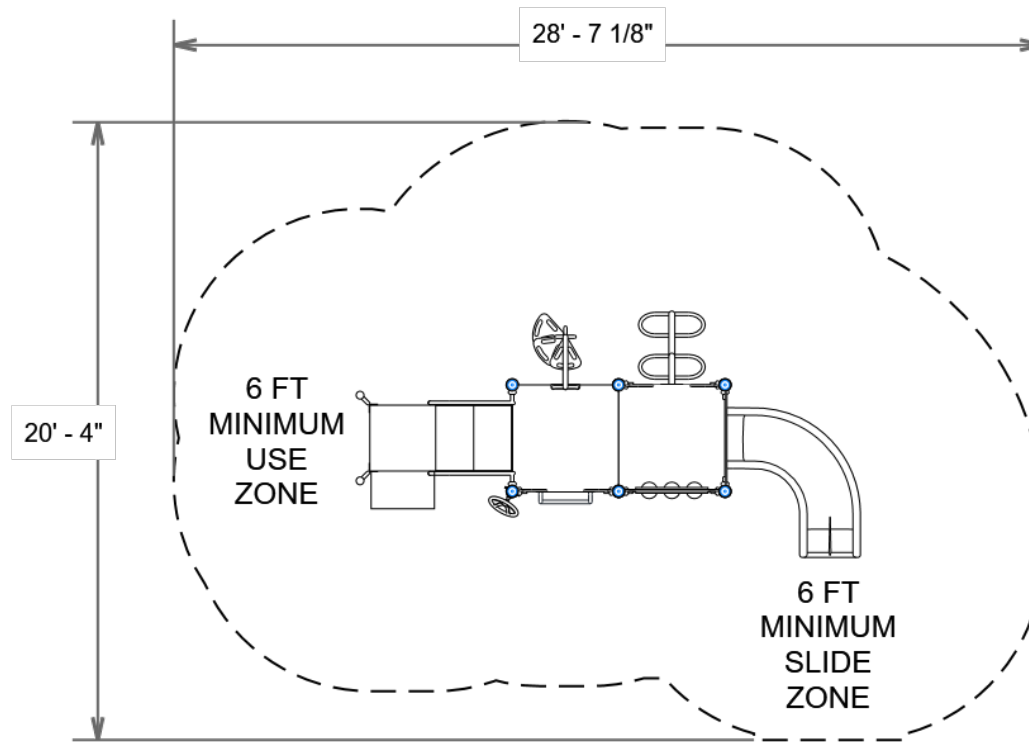


GENERAL NOTES:
