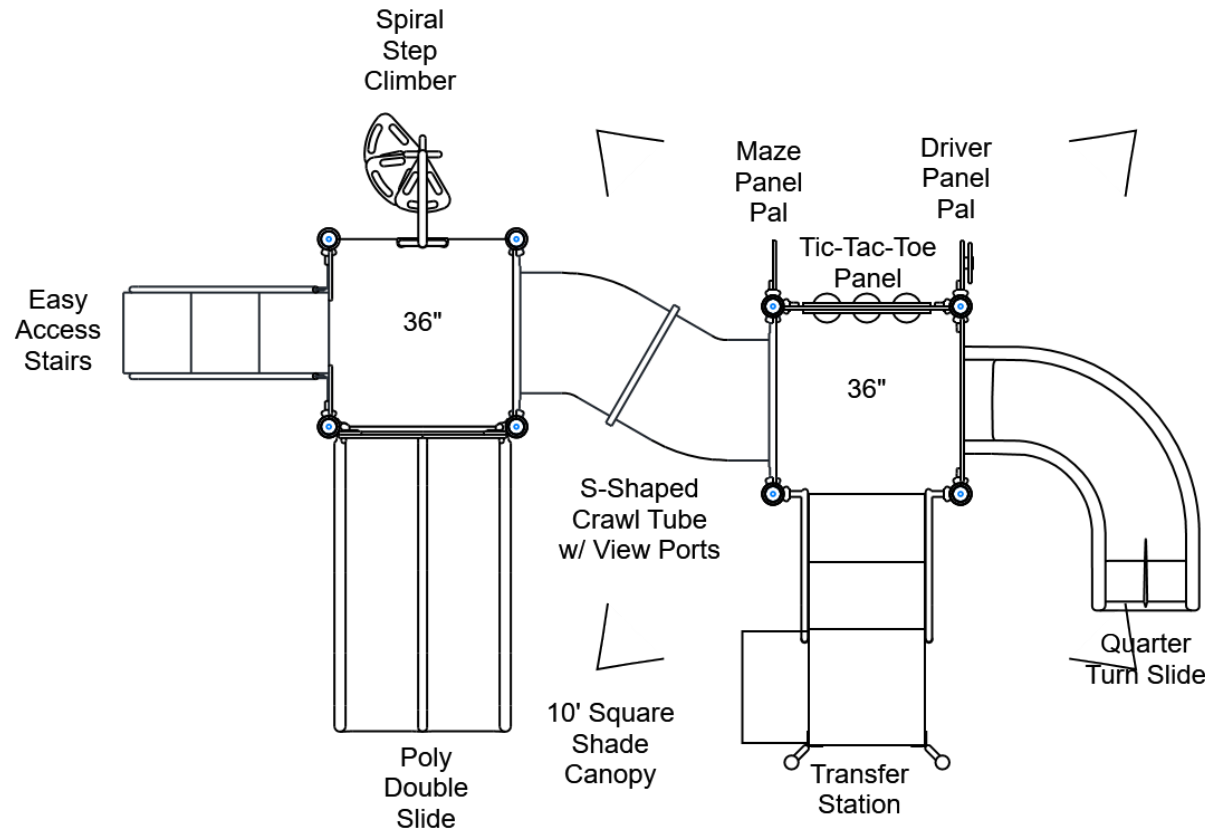

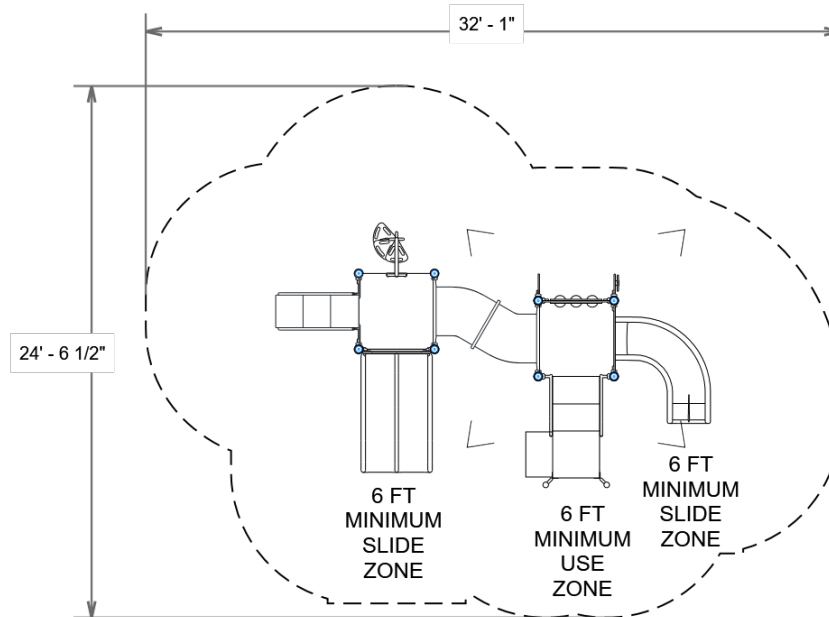


GENERAL NOTES:

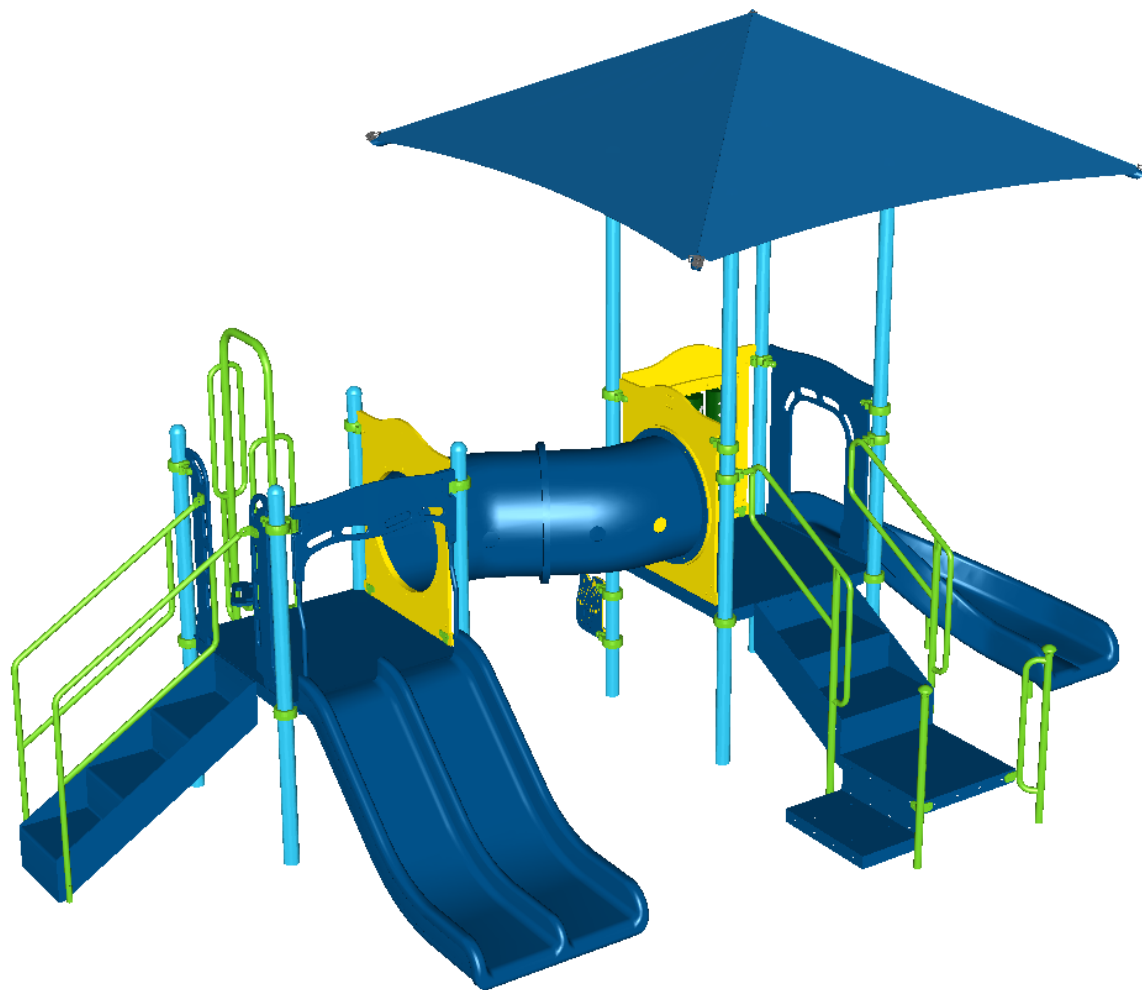
