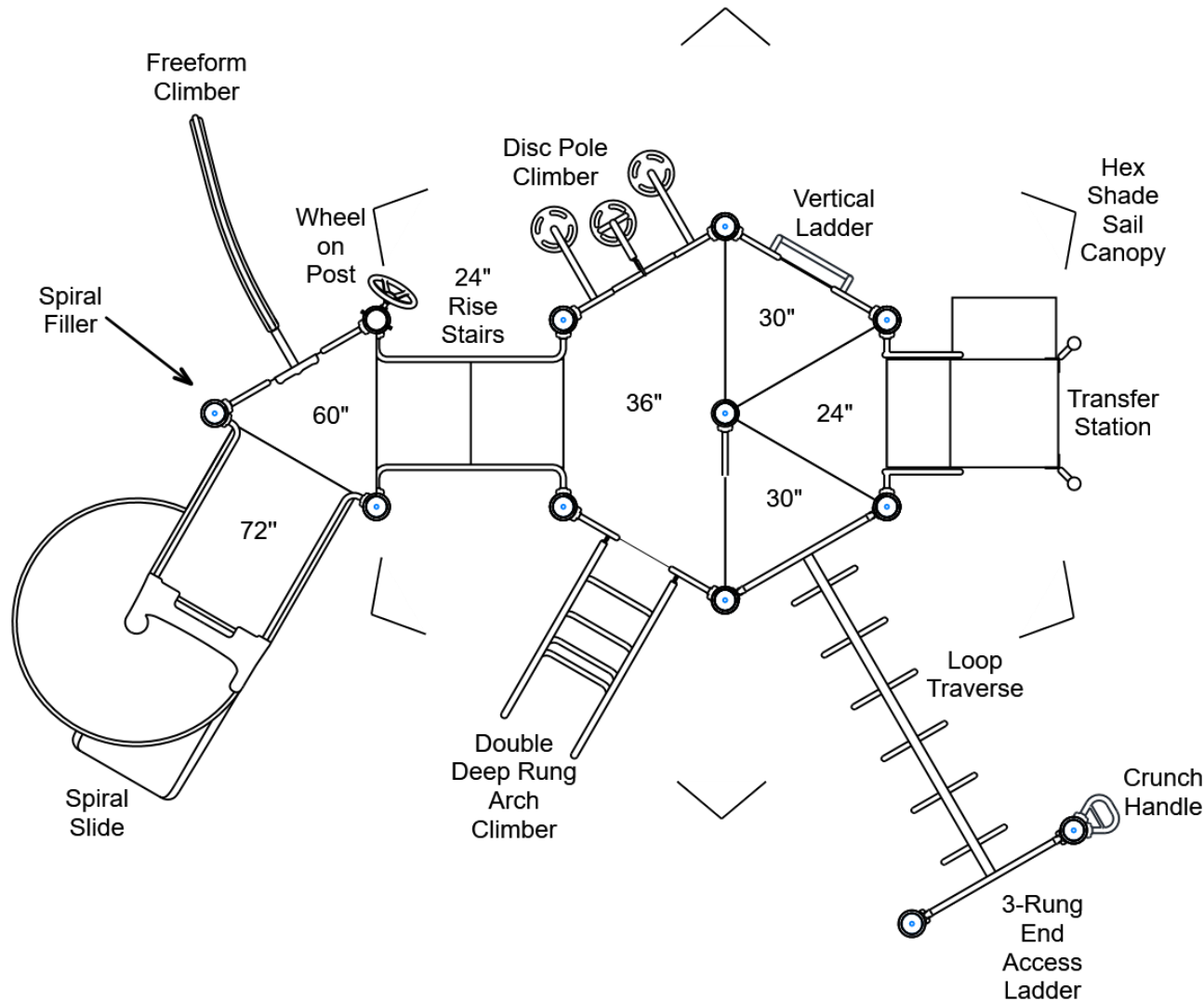

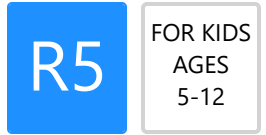

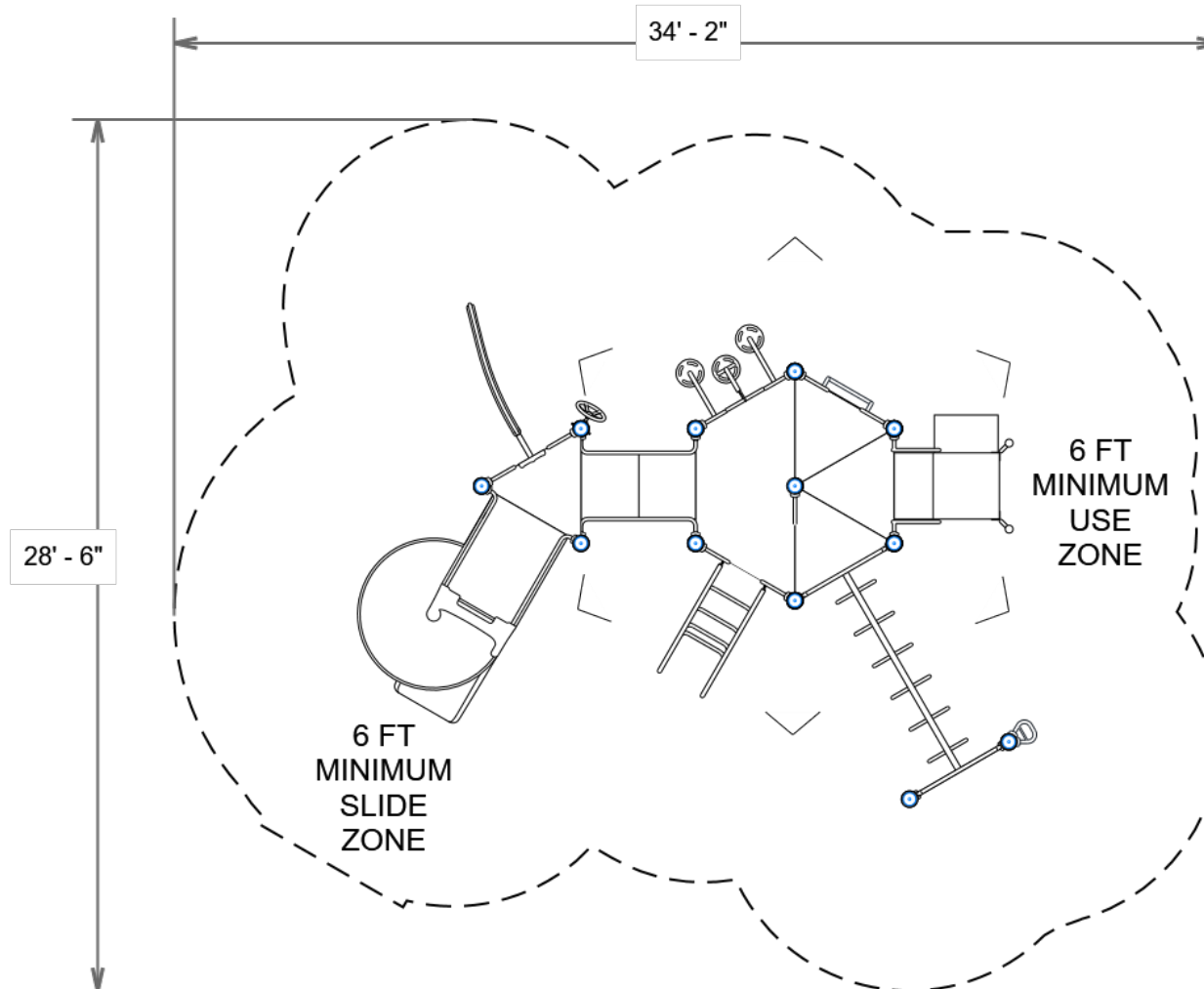


GENERAL NOTES:
